
PLAT OF SURVEY Or

DESCRIBED AS FOLLOWS:

Commencing at the Southeast corner of Section 28, aforesaid; thence North 0°00'00" East 1996.41 feet; thence North 89°40'21" West 458.01 feet to the place of beginning for the land to be herein described; thence continuing North 89°40'21" West 817.24 feet to the East right-of-way line to C.T.H. "M"; thence North 1°36'18" West along said right-of-way line 402.46 feet to a point of curve; thence Northerly along a curve convexed Easterly 320.03 feet, having a radius of 2799.59 feet, the chord being North 3°39'05" West 319.86 feet to a point of reverse curve; thence Northerly along a curve convexed Westerly 409.59 feet, having a radius of 1769.21 feet, the chord being North 2°01'20" West 408.68 feet to a point of tangency; thence North 6°32'38" East 211.50 feet to a point of curve; thence Northerly along a curve convexed Easterly 172.01 feet, having a radius of 5618.76 feet, the chord being North 5°50'54" East 172.00 feet; thence South 88°27'51" East 503.88 feet; thence South 16°33'31" East 1000.58 feet; thence South 4°55'01" East 387.08 feet; thence South 50°03'15" West 15.32 feet; thence South $4^{\circ}23'51"$ East 148.18 feet to the place of beginning.
