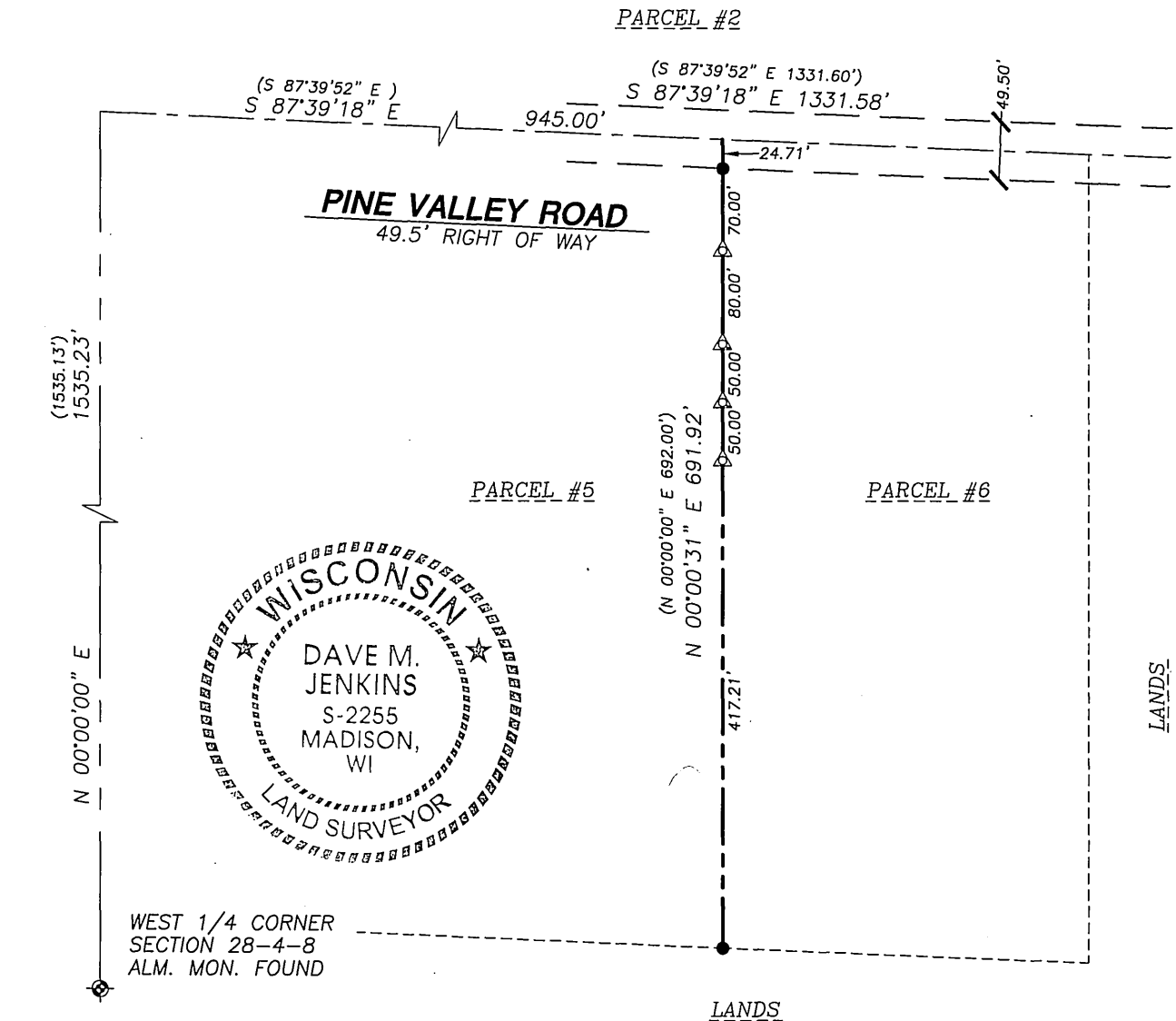


PLAT OF SURVEY

LEGAL DESCRIPTION - PARCEL 6 (FURNISHED)

THAT PART OF THE NW 1/4, SECTION 28, TOWN 4 NORTH, RANGE 8 EAST, GREEN COUNTY, WISCONSIN, BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE WEST 1/4 CORNER OF SAID SECTION 28; THENCE DUE NORTH ALONG THE WEST LINE OF THE NORTHWEST 1/4 OF SECTION 28, 1535.13 FEET TO THE CENTERLINE OF A TOWN ROAD; THENCE S 87°39'52" E ALONG SAID CENTERLINE, 945.00 FEET TO THE TRUE POINT OF BEGINNING OF THE LANDS BEING DESCRIBED; THENCE CONTINUING S 87°39'52" E ALONG SAID CENTERLINE 315.00 FEET; THENCE SOUTH, 692.00 FEET; THENCE N 87°39'52" W 315.00 FEET; THENCE NORTH 692.00 FEET TO THE POINT OF BEGINNING; CONTAINING 5.00 ACRES.

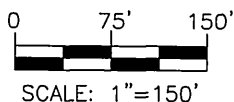
