DESCRIPTION: That part of Lots 2 and 3 of Certified Survey Map 732 (Volume 2, Page 292-293) in the Northwest and Southwest quarters of the NE1/4 and the NW1/4 of the SE1/4 of Section 26, T4N, R7E, Town of New Glarus, Green County, Wisconsin, bounded and described as follows:

Commencing at the NE1/4 corner of said Section 26; thence S89°49'22"E, along the North line of Section 26, 420.00 feet; thence S0°01'42"E, 739.74 feet to the point of beginning; thence S0°01'42"E, 154.92 feet; thence Southeasterly, 301.06 feet along the arc of a curve to the left whose radius is 230.00 feet and whose chord bears S79°52'10"E, 280.02 feet; thence N62°37'56"E, 125.61 feet; thence Southeasterly, 104.23 feet along the arc of a curve to the right whose radius is 100.00 feet and whose chord bears S87°30'33"E, 99.57 feet; thence Southeasterly, 225.01 feet along the arc of a curve to the left whose radius is 520.00 feet and whose chord bears S70°02'49"E, 223.26 feet; thence Southeasterly, 164.03 feet along the arc of a curve to the right whose radius is 100.00 feet and whose chord bears S35°27'12"E, 146.25 feet; thence S11°32'12"W, 100.26 feet; thence Southwesterly, 118.94 feet along the arc of a curve to the right whose radius is 550.00 feet and whose chord bears S17°43'55"W, 118.71 feet; thence S23°55'38"W, 184.49 feet; thence Southwesterly, 78.30 feet along the arc of a curve to the right whose radius is 100.00 feet and whose chord bears S46°21'32"W, 76.32 feet; thence S21°12'34"E, 60.00 feet; thence S0°01'42"E, 1355.53 feet; thence S89°35'47"E, 302.59 feet; thence N0°01'42"W, 1447.49 feet; thence N89°49'22"W, 211.42 feet; thence N23°55'38"E, 177.71 feet; thence Northeasterly, 131.92 feet along the arc of a curve to the left whose radius is 610.00 feet and whose chord bears N17°43'55"E, 131.66 feet; thence N11°32'12"E, 100.26 feet; thence Northwesterly, 262.44 feet along the arc of a curve to the left whose radius is 160.00 feet and whose chord bears N35°27'12"W, 234.00 feet; thence Northwesterly, 199.05 feet along the arc of a curve to the right whose radius is 460.00 feet and whose chord bears N70°02'49"W, 197.50 feet; thence Northwesterly, 166.76 feet along the arc of a curve to the left whose radius is 160.00 feet and whose chord bears N87°30'33"W, 159.32 feet; thence S62°37'56"W, 125.61 feet; thence Northwesterly, 348.15 feet along the arc of a curve to the right whose radius is 170.00 feet and whose chord bears N58°41'53"W, 290.42 feet to the point of beginning.
