

**LEGAL DESCRIPTION OF PARCEL 'A'**

A parcel of land located in the SW 1/4-SW 1/4 of Section 23 and the NW 1/4-NW 1/4 of Section 26, Town 1 North, Range 6 East, Town of Cadiz, Green County, Wisconsin, described as follows:

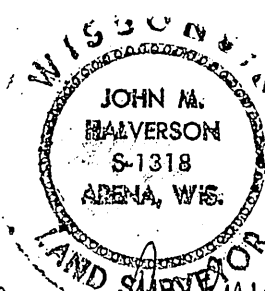
Beginning at the Northwest corner of said Section 26; thence S 00°51'27" E, 295.26 feet along the West line of the NW 1/4-NW 1/4 of said Section 26 to the point of beginning of a meander line of the Northwesterly bank of Honey Creek, said point being N 00°51'27" W, 57 feet, more or less, from the centerline of Honey Creek; thence S 16°06'19" E, 49.74 feet along said meander line; thence S 83°31'32" E, 267.36 feet along said meander line; thence N 21°12'12" E, 130.00 feet along said meander line; thence N 45°59'33" W, 159.54 feet along said meander line; thence N 04°23'59" W, 92.90 feet along said meander line; thence N 85°07'43" E, 202.19 feet along said meander line; thence N 58°27'58" E, 69.36 feet along said meander line; thence N 15°58'16" E, 239.70 feet along said meander line; thence N 66°24'51" E, 115.99 feet along said meander line; thence N 56°37'00" E, 94.72 feet along said meander line to a point in the centerline of Allen Road and the end of said meander line, said point being N 36°24'00" W, 25 feet, more or less, from the centerline of Honey Creek; thence S 36°24'00" E, 79.30 feet along the centerline of Allen Road; thence N 38°17'37" E, 117.41 feet; thence N 53°53'46" E, 234.22 feet; thence S 52°47'21" E, 359.12 feet; thence N 00°58'26" W, 879.65 feet along the East line of the SW 1/4-SW 1/4 of said Section 23; thence S 48°11'23" W, 761.10 feet; thence N 35°43'08" W, 6.00 feet; thence S 73°57'31" W, 108.18 feet; thence S 63°54'03" W, 7.75 feet; thence S 34°29'40" W, 64.00 feet; thence N 87°46'06" W, 176.07 feet; thence S 11°45'08" E, 196.50 feet; thence N 78°04'20" E, 28.00 feet; thence S 21°15'00" E, 142.20 feet; thence S 19°43'00" E, 19.00 feet; thence S 21°50'48" W, 108.94 feet; thence S 43°31'49" W, 99.00 feet; thence S 66°47'02" W, 157.66 feet; thence S 00°54'04" W, 8.26 feet; thence S 89°52'42" W, 279.02 feet to the point of beginning, INCLUDING all land southerly of the above described meander line and northerly of the centerline thread of Honey Creek. Said parcel contains 11.61 acres, more or less, to the above described meander line, or 12.30 acres, more or less, to the centerline thread of Honey Creek.
