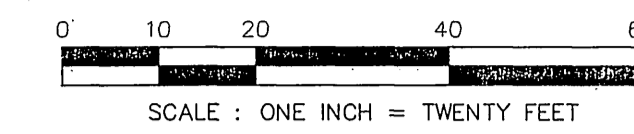


PLAT OF SURVEY

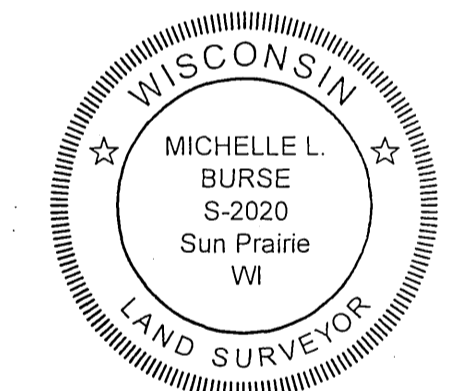

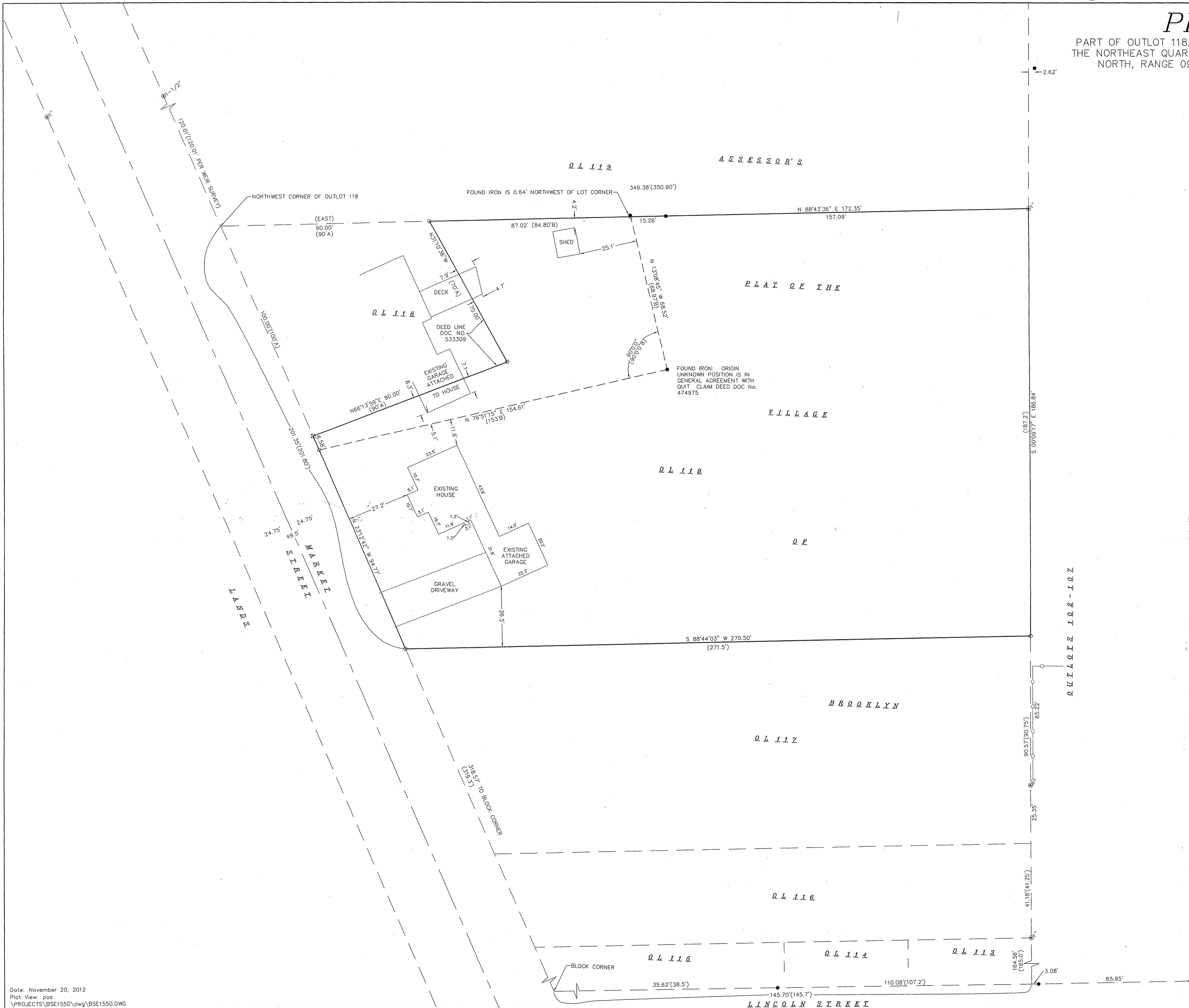
